# FSSC Development Program transition Version 1.1 to Version 2.0

*FSSC Development Program*, the conformity evaluation program mainly focused on SMEs that wish to meet food safety requirements according to a framework established by FSSC, is currently undergoing an update and transition period. This transition corresponds from Version 1.1 to its new Version 2.0, which was published on May 20<sup>th</sup>, 2025.

## 1.- Transition timeline

Global Standards will be managing the following transition period to ensure compliance with the dates set by the Foundation FSSC:

- Audits under the requirements of Version 1.1 may be carried out until April 17<sup>th</sup>, 2026.
- Audits under the requirements of the new Version 2.0 may begin being performed as of June 1<sup>st</sup>, 2025.
- ALL audits as of June 1<sup>st</sup>, 2026 shall be performed under the new Version 2.0 requirements.
- Certificates issued under version 1.1 shall be effective for the date described on the certificate, provided that this effective date does not exceed May 31<sup>st</sup>, 2027.
- No certificate issued for version 1.1 will be effective after May 31<sup>st</sup>, 2027.

#### 2.- Main reasons for the update to Version 2.0

FSSC Development Program was updated due to the following reasons:

- Expansion of the program scope to include Category I: Packaging.
- Adjustment in the timing of the evaluation audits for better applicability to small organizations.
- Increased visibility and strengthening of the program with organizations and consumers.

## 3.- Main changes to Version 2.0

- Transition to a single level of conformance aligned with Level 2 of the 1.1 version.
- Complete HACCP system in line with ISO 22000, including critical control points (CCP) and operational prerequisite programs (OPRP).
- Change from a question-based to a requirements-based document structure.
- Elimination of duplication of requirements and clarification of documentation requirements.
