GLOBALG.A.P. transition from IFA v5.2 to IFA v6 SMART (Scopes: Plant Propagation Material and Combinable Crops)

GLOBALG.A.P. IFA for the scopes Plant Propagation Material and Combinable Crops, is currently undergoing an update and transition period. This transition corresponds from IFA v5.2 to its new IFA v6 SMART, which was published on July 08th, 2025.

1.- Transition timeline

Global Standards will be managing the following transition period to ensure compliance with the dates set by scheme owner GLOBALG.A.P.:

- Audits under the requirements of the new IFA v6 SMART may begin being performed as of December 1st, 2025.
- Audits under the requirements of IFA v5.2 may be carried out until April 30th, 2026.
- ALL audits as of May 1st, 2026 shall be performed under the new IFA v6 SMART requirements.

2.- Certicates validity

- Certificates issued for IFA v5.2 shall be valid for the full one cycle year described on the certificate.
- No certificate issued for IFA v5.2 shall be valid after April 30th 2027.

3.- Main reasons for the update to IFA v6 SMART

The main reason for updating the IFA v5.2 standards in the Plant Propagating Material and Combinable Crops scopes to IFA v6 SMART is the alignment with the rest of the IFA v6 standards in terms of environmental responsibility, worker health and safety criteria.

4.- Main changes to IFA v6 SMART

Plant Propagation Material

- The plant propagation material product category is delinked from the topic of food safety, therefore products certified as plant propagation material cannot claim food safety.
- In addition to good agricultural practices, a specific focus is added to the traceability of propagation material and the plant health of the propagation material obtained.
- A new Principle and Criteria is added that requires the producer to be aware of the risks and critical steps in production to control the traceability, origin and plant health of the propagation material.

Combinable crops.

- Alignment with IFA v6 standards and more specifically with IFA v6 SMART for fruit and vegetable scopes.
- Topics like environmental responsibility, workers' health, safety and welfare as well as elements on food safety, production processes and traceability.
- Principles and criteria (P&Cs) specific to the postharvest handling and long-term storage of combinable crops have been addressed in v6 SMART.
